The addition of ESG-CV2 funds will allow the County to provide supplemental funds to emergency shelters that are housing individuals during and following the pandemic. While in the emergency shelters, homeless households will be assisted in gathering the necessary documents to move into permanent housing as quickly as possible.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

CARES Act, ESG-CV2 Substantial Amendment

ESG-CV2 funds will allow additional rapid rehousing and street outreach to reach out to additional persons experiencing homelessness and connect them to permanent housing. These dollars will be used to fund Crossroads, a project-based rapid rehousing program, provide additional rapid rehousing and emergency shelter funding to the Housing and Disability Advocacy Program, and it will provide a housing matcher and community coordinator to the Fresno Madera Continuum of Care. The County will continue to follow the Housing First model to ensure that individuals assisted with ESG funds are quickly connected to housing and with resources to ensure long-term success.
