## AGENDA

I. Welcome and Introductions

The FMCoC LEAB welcomed one new member that was voted onto the LEAB at the May meeting. The other new member that was voted onto the LEAB in May did not join the meeting. An orientation was offered to the new member.

II. City of Fresno Presentation: Homekey Project Round 3 (Slides available in public folder)

This was rescheduled.

III. Action Item: 1 Membership Application Review + Membership Application Discussion (Maya and Alex)

The vote and membership application review were rescheduled until additional applications are obtained and until it is clear whether the second member voted onto the LEAB will join.

The members discussed that the application process should be confidential and members vote on applications presented anonymously. Members brought up that applicants have contacted them and asked them to for them to be on the FMCoC LEAB. The members decided that this should disqualify an applicant, and Maya Spark agreed to bring proposed language to add to the membership application to the July meeting stating this.

IV. CoC Treasurer Presentation: CoC Budget Process (Misty)

Misty said that the creation of a proposed 2024 LEAB budget should start being added as a regular agenda item to work on starting this fall so that it can be presented to the Board and General Membership at the November or December 2023 meetings for approval.
