#### MEETING SUMMARY

The LEAB approved new language for the membership application that warns applicants about requesting that LEAB members vote for them to be on the LEAB.

III. Review City of Fresno Ordinance Status, CoC Involvement, and Shelter Access During Sweeps

The LEAB reviewed the letter to the City of Fresno regarding the new Ordinance Criminalizing Homelessness that the CoC will vote on Thursday. LEAB Members discussed their experiences with the HART team and encampment sweeps and raised that people should be offered shelter and a place to store their belongings when being ordered to move.

  - Letter Signed by Working Group Comprised of Persons with Lived Experience of Homelessness. The letter must be signed by either (1) at least three members involved in the working group (e.g., advisory committee, subcommittee) comprised of individuals with lived experience or (2) an authorized representative of the workgroup (e.g., a working chair) along with evidence that the person is authorized to represent the group; and the letter must demonstrate support of the priorities for serving individuals and families experiencing homelessness with severe service needs in the CoC's geographic area.
