## **Racial Equity**

### **Racial Disparity Assessment**

1. When was the most recent formal or informal assessment of racial or ethnic disparities for the population experiencing homelessness or housing instability completed within your service area?

#### 2. How has your jurisdiction formed its racial equity strategy based on a local assessment of racial disparity?

The Fresno Madera Continuum of Care (FMCoC) collects data through the Homeless Management Information System, input from community partners, and a Lived Experience Advisory Board comprised of Black, Native, and Indigenous, Latinx, Asian, Pacific Islander, and other People of Color experiencing homelessness and former homeless persons, to inform the development of goals that focus on addressing racial disparities in access to and positive housing outcomes from homeless assistance services as well as reducing homelessness for underserved and/or disproportionately impacted groups. The FMCoC is also forming review committees to evaluate the Coordinated Entry System for racial bias, as well as a review panel of volunteers from community-based organizations, service providers, and local government representing underserved and/or disproportionately impacted groups to review HMIS data to verify equitable access to services.

### **Findings**

1. Describe the disparities you see among racial and ethnic groups of those experiencing homelessness in your community in comparison to the general housed population.

When comparing the general housed population to the homeless population in the community, Black or African American and American Indian or Alaska Native populations are disproportionately impacted by homelessness. Black or African American populations make up 4.4% of the total population while making up 23.5% of the homeless population and American Indian or Alaska Native populations make up 1.2% of the total population but make up 10% of the unsheltered homeless population.

2. In looking at the population of individuals experiencing homelessness within your community, describe the disparities you see among racial and ethnic groups of those more or less likely to receive homeless assistance.

Black or African American and American Indian or Alaska Native populations are underserved by homeless assistance. The FMCoC plans to develop a system of ongoing analysis regarding equitable access to services to reduce the disparities affecting these populations. Included in this plan is a Coordinated Entry Assessment Tool ad hoc committee to develop a revised CES prioritization tool that equitably evaluates vulnerability among Black, Native, and Indigenous,

Latinx, Asian, Pacific Islander, and other People of Color.

3. In looking at the population of individuals experiencing homelessness within your community, describe the disparities you see among racial and ethnic groups of those more or less likely to have a positive housing outcome.

Among groups that had positive housing outcomes, Black or African American, Asian, and American Indian or Alaska Native people experiencing homelessness had fewer positive exits when comparing population size. The FMCoC recognizes that the success rate increases when those experiencing homelessness identify with those providing services and has developed goals to reduce this disproportionality of exits through a system of ongoing analysis regarding equitable exits to permanent housing.

### **Racial Equity Technical Assistance Needs**

1. Based on the information provided above, what type of racial equity technical assistance could your community benefit from?

The FMCoC could benefit from Technical Assistance on equitable access to shelter facilities for disproportionately impacted groups and Technical Assistance for provider agencies on reflecting the people served, equitable hiring practices and language access.

## **Partnerships**

1. Please share a successful partnership as a result of HHAP-1 funding and describe what made that partnership successful.

The budget and service plans for HHAP funding have been increasingly integrated with joint planning for both funding and service coordination. One example is the collaboration between the City, County, and CoC whereby funding from the City has been used to pick up where the CoC and County funding has been depleted to enable the City to continue providing the 50-bed Navigation Center program with Mental Health Systems, Inc. in Fresno, CA for an additional 24 months.

2. Please share the most significant barrier(s) to HHAP-1 partnerships and any steps you took to mitigate the barrier(s).

As with much of the funding coming from various sources to the local level, funding awarded to multiple entities is subject to the administrative requirements and priorities of each entity. This can make it challenging to align services across the community. Communication is also a challenge due to the number of individuals involved at the planning and administrative level. HHAP funding requires entities to come together to identify the needs of the community and gaps in meeting those needs, for each entity to communicate a clear direction for addressing the gaps, and for each entity to do its part in advocating for a common solution for the entire continuum.
